

Baltic Hub profile regulations on Facebook.com

The "Baltic Hub" profile is the official channel of Baltic Hub Container Terminal on Facebook.com.

The regulations define the rules and conditions for posting comments on the profile and are intended to facilitate its use by all users. The introduction of regulations does not mean limiting the possibility of conducting discussions or sharing opinions. The rules aim to eliminate hate speech, ridicule and insulting other website users, slander, as well as spam and the promotion of fake news. We encourage you to follow them in order to maintain the level of discussion and build an atmosphere of mutual respect.

At the same time, we would like to point out that the profile is not an official channel for taking any formal actions related to the activities of the Baltic Hub.

General provisions

1. The administrators of the "Baltic Hub" profile on Facebook.com (www.facebook.com/BalticHubContainerTerminal), hereinafter referred to as the Baltic Hub profile/profile, are Baltic Hub employees.
2. The Regulations define the general rules for using the "Baltic Hub" profile, as well as the rights and obligations of Users and the rights and obligations of employees related to the administration of the profile.
3. Each User using the "Baltic Hub" profile on Facebook.com is obliged to read the Regulations in advance and comply with their provisions.

Definitions

The terms used in the Regulations mean:

1. Regulations - this document collecting the rules for using the "Baltic Hub" profile on Facebook.com;
2. "Baltic Hub" profile - a subpage on the social networking site Facebook.com, through which Baltic Hub conducts promotional and communication activities, available at <https://www.facebook.com/BalticHubContainerTerminal>;

3. User – a natural person, a legal person or an organizational unit without legal personality that visits and uses the "Baltic Hub" profile;
4. Content – all comments, statements and materials posted on the "Baltic Hub" profile;
5. Netiquette - a set of rules regarding good behavior on the Internet;
6. Trolling - intentionally influencing other users in order to ridicule or offend them by adding controversial, offensive, often untrue statements.

Using the "Baltic Hub" profile on Facebook.com

For the sake of the quality of the discussion, we encourage everyone to follow the rules of Netiquette, respect other Users of the "Baltic Hub" profile and publish content responsibly.

1. We encourage you to post statements that comply with the rules of spelling and the correct use of words and polite expressions.
2. When following the rules of Netiquette, do not write only in CAPITAL or alternating CaPiTaL and SmAiL LeTtErS, and do not overuse emoticons - remember that it is an addition to the entire statement, not its main part.
3. Each person using the "Baltic Hub" profile is obliged to show respect to other Users. The right to property on the Internet should also be respected - when publishing a photo or quoting a statement, the author and source should be provided.
4. The User is solely responsible for the consequences of the User's actions, consisting in posting specific comments, opinions or other content on the "Baltic Hub" profile on Facebook.com.
5. The following are considered violations of the provisions of the regulations:
 - 5.1. Spam is understood as content published by bots, promotional entries, publications that threaten the proper functioning of the website/profile and expose the profiles of other Users to negative effects. In particular, the following may be considered Spam:
 - a) A post from a fan or other website/profile of a purely promotional nature;
 - b) Post by a fan encouraging other fans to take part in a commercial event;

- c) A fan's post encouraging other fans to invite their friends to:
 - Commercial fanpage;
 - Commercial group;
 - Commercial event;
- d) A fan's post urging fans to take part in a commercial competition;
- e) A fan's post encouraging other fans to vote for the competition object;
- f) Crypto advertising.

5.2. Posting comments that may be generally perceived as offensive or violating the norms of good manners, including in particular erotic, pornographic, brutal, vulgar content, etc.

5.3. Posting comments and materials that violate the law or the principles of good social coexistence. Trolling is also not allowed. Cultural, substantive statements based on facts are welcome on the profile.

5.4. Publishing misleading information and spreading the so-called fake news.

6. The Administrator is not responsible for the inability or difficulties in using the profile resulting from reasons attributable to the User or the Facebook.com social networking site.

7. The Administrator's liability for actions towards the User and third parties in connection with the use of the "Baltic Hub" profile on Facebook.com is excluded.

8. To ensure the protection of users' data, they are not required to provide personal data such as:

- a) PESEL number,
- b) ID card number,
- c) personal account number,
- d) health condition, etc.

Due to the possibility of phishing of personal data, users take responsibility for the posted personal data, both their own and those of third parties.

9. Users have the right to express their opinion.

10. Each User opinion is treated as a private, subjective opinion on a specific topic.

11. Discussions between Users may be held on the profile, provided that the previously mentioned rules of using the profile are followed.

12. It is prohibited to post content that is racist, homophobic, sexist or that insults other religions, beliefs or nations. Propagating fascist or other totalitarian ideologies is not allowed.

13. It is prohibited to post comments containing slander, slander and lies about entities active on the "Baltic Hub" profile.

Violation of the provisions of the Regulations

1. The administrators of the "Baltic Hub" profile on Facebook.com reserve the right to delete or hide entries that violate the rules of these regulations.

2. Content that is repeated in threads and does not add value to the discussion on the profile will be left unanswered or deleted.

3. The Administrator reserves the right to block the User when:

a) The User uses the "Baltic Hub" profile in violation of applicable laws and the provisions of these Regulations;

b) The Username is illegal, contrary to decency, is an expression generally considered offensive or suggests that it is a profile used by Baltic Hub, which may mislead other Users.

Rules regarding the protection of personal data

1. By selecting "Follow", "Like!" or posting reactions and comments under posts. The User consents to the processing of his/her personal data posted on Facebook.com in order to actively participate in the activities of the "Baltic Hub" profile on this platform.

2. The administrators of Users' personal data are Facebook.com and the administrator of the "Baltic Hub" profile.

3. The Users' personal data are the information they entered when registering on Facebook.com, in particular: profile name and profile photo.

4. The User has the right to access his or her personal data, correct it, transfer it, delete it or limit its processing, the right to object to data processing and to lodge a complaint with the supervisory authority, which is the President of the Office for Personal Data Protection.

Final Provisions

1. These Regulations are valid from the moment they are posted on the "Baltic Hub" Facebook profile.
2. Baltic Hub Container Terminal, as the owner of the website, has the right to terminate the operation of the "Baltic Hub" profile on Facebook.com at any time. The user is not entitled to any claims against the website owner in connection with the possible closure of the profile.
3. If any of the provisions of the Regulations are invalid, the validity of the remaining provisions shall not expire. Outdated provisions will be replaced by similar provisions.
4. In all matters not regulated in these Regulations, the provisions contained in the Facebook.com website regulations apply: <https://www.facebook.com/legal/terms>.
